- All income statements: W-2, and 1099, 1099-R, S.S Benefits Statement and other sources
- Identification number for child care provider
- 1098 -T tuition statement for college and technical school

- Account and routing numbers of your financial institution (for direct deposit of any refund)
- Forms 1095-A, B or C, Affordable Health Care Statements
